

## Bibliography Of The Revenue Stamps Of The United States' Territories, Possessions and Occupied Areas

On August 20, 1893, the first revenue stamps of the United States Military Government in the Philippines were issued. With that act, the first distinctive revenue stamps issued for use in a United States territory were born. Within a little more than a year, these stamps had been duly noted in the philatelic press. Since that time, over 200 articles have been written on the various revenue stamps used in the United States' territories and zones of military occupation.

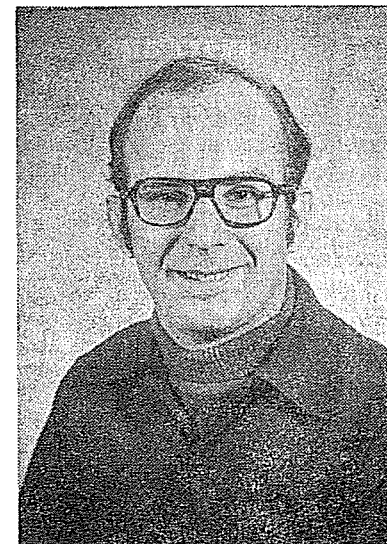
In compiling this bibliography, I have attempted to make it exhaustive, on the theory that even the smallest bit of information may be of use to some researcher. The listing includes unpublished manuscripts as well as published material. It is limited, however, inasmuch as no attempt has been made to list literature which deals solely with the revenue stamps issued for use before or after United States administration (e.g., the Philippines since independence and during the Spanish period). Also, in those instances where a territory has subsequently become a state, material dealing solely with post-territorial revenues has been excluded.

Although I have attempted to make this listing exhaustive, I am confident that I have missed some relevant literature. Elliot Charles Chabot, who compiled the bibliography on revenues of U. S. possessions and the cumulative index to the *Embossed Revenue Stamped Paper News*, is currently a second year student at the George Washington University Law School in Washington, DC. At the relatively tender age of 23, he is already well known for his *Catalogue of the Revenue Stamps of the United States' Possessions and Zones of Military Occupation* (1st ed. 1977, with a second edition anticipated in 1979), and has authored a number of articles which have appeared in *American Revenuer* and other philatelic periodicals. Mr. Chabot's philatelic affiliations include the ARA and other leading revenue groups, major organizations dealing with study of the philately of former U. S. possessions, the American Philatelic Congress, the APRL, and Friends of the Western Philatelic Library. The depth of his philatelic scholarship as shown here, combined with his diversity of interests, suggests that Mr. Chabot will be one of the leading philatelic authors in years to come.
