Preface

The following bibliography was compiled to acquire a dated list of known publications of the kinds indicated in the title. This seemed to be an appropriate project since bibliographies provide a handy compendium of what has gone before, and it should hardly need noting that studies currently in progress or anticipated are best carried out with knowledge of what has been published at various times in the past. No recent extensive bibliography of this sort is available. Further it was realized that there are individuals, bibliophiles, who collect philatelic literature, perhaps in despair of finding or affording many of the items reported in the philatelic literature, and that such a document would prove interesting to collectors of that type. Finally, it was expected that comparison of such a bibliography with holdings in the American Revenue Association Library would result in a shopping list of significant missing titles, and thus to best use of a limited Association budget.

Many individuals have contributed information and in other ways and their assistance is gratefully acknowledged. Introduction

Area Covered

A revenue stamp for present purposes will be considered to be a marking, or marker, be it embossed or adhesive, used to denote the payment of a federal, state or local tax, but NOT those stamps used solely in connection with carrying the mail or railway packages or deferring the cost of a telegram.

Examples of items which are included here are for example books, pamphlets and catalogues* dealing with topics such as British Columbia revenue stamps; South African cigarette tax paid and the stamps which played a part in the start of the Revolutionary War. So too are books, etc. of which but a portion or chapter is devoted to revenue stamps such as general catalogues and broad scope works on stamps of all sorts from a particular country of which a portion is devoted to fiscal emissions.

Entries on the periphery which have been considered to qualify include books, pamphlets, etc. dealing with fiscal usage of so called postal fiscals of some British Colonies and certain newspaper stamps used at a period of time when they defrayed, at least in part, a tax on the printed publication. A small amount of material dealing with facsimiles and license and royalty stamps is also included at the whim of the compiler.

Gray areas as usual present problems. The catalogue can be used to illustrate one such problem. 19th century catalogues developed from price lists of larger retail stamp outlets. In time some acquired an aura of authority and several became less and less price lists of stamp merchandise on hand, but rather developed into catalogues of known items, which the publisher might or might not have in stock for sale. Several of the better known 19th century dealers price lists of this type which saw annual revision are included. No doubt many have been missed.

Recent 20th century publications present an array from the catalogue at one end, compiled by a publisher with no commercial interest in the material listed, to an illustrated net price sale list at the other. Somewhere about midpoint listing of the latter half ceased.

There is no question that useful information is to be found in auction catalogues, especially well illustrated ones and those of particularly illustrious collections, but they have been omitted from the bibliography at this time as at least two philatelic libraries are presently attempting to organize this segment of the philatelic literature. Also omitted are the myriads of federal, state and local government publications regarding taxes and their collection utilizing revenue stamps of various sorts. Seekers of such material are directed to government document collections found in most larger libraries. References to unpublished works, unique scrap-

books and the like, several of which are to be found in almost any philatelic library have also been omitted.

No attempt has been made to include material from the serials literature unless it appeared as a separate reprinted entity or as a journal addendum generally available off subscription. This somewhat arbitrary segregation of material from the serials literature was made, regretfully, to avoid endless subjective decisions about what to include and what to exclude. Even so it has not been always easy to classify some publications. Thus the numerous publications of the Canadian Revenue Society appearing between 1941 and 1954 could be classified as serials but are included here. The serials literature may be treated separately at a later date.

No apology is tendered for particular inclusions or omissions as there is no such thing as a complete bibliography, one meeting the diverse views of appropriateness of different users. On the other hand, overt omissions through oversight no doubt exist and the author would appreciate their being brought to his attention. In fact a handful of unlisted fragmentary citations are on hand for which adequate confirmatory documentation has not as yet been found.

Compilation of the Bibliography

Several general bibliographies confined to listing books, pamphlets, catalogues and monographs about revenue stamps of the world have been published in the past and they provided the nucleus to which this listing adds. Examples are: George T. Turner, *List of Handbooks and Catalogues pertaining to [U.S.] Revenue Stamps*, *American Philatelist* 52, 446-8, 1939; Josef Schonfeld, *A Selective Bibliography of Literature on Revenue Stamps*, Schonfeld, 1954; H.E. Tester, *Literature of Cinderella Philately*, Cinderella Stamp Club, London, 1972; G. M. Abrams, *Worldwide Revenue Literature*, *Philatelic Literature Review* 28, 25-9, 1979; *Biennial Directory*, The American Revenue Association, 1982, pp. 74-86; and [Conrad Graham], *The Cinderella Stamp Club Library List*, London, 1983.

There are many other sources of titles in which revenue stamp literature is included. A superb guide to such sources is found in an article by John Boyton Kaiser: *Bibliography. The Basis of Philatelic Research*. *American Philatelic Congress Book* 19, 3-20, 1953. Many of the lists mentioned by Kaiser have been consulted. Since Kaiser's paper was prepared a more recent list of titles held by the Collector's Club of New York has become available as: *Philately. A Catalog of the Collectors Club Library*, New York City, G. K. Hall & Co., Boston, MA, 1974, and this has proven to be most useful. Of course *The National Union Catalog*, *The Library of Congress Catalog* and *The British Library General Catalogue of Printed Books* have been consulted.

Personal verification of details of many citations given in this bibliography was possible through examination of material in the Los Angeles Philatelic Club Library and in the Library of the American Revenue Association. All citations examined personally and those referenced in two apparently

unrelated bibliographies or references are considered verified and identifiable as given. Items in the bibliography not seen and found in only a single bibliographic source include in their citation a reference to the citing source and should be considered in that context as unverified, although sources which have been cited are deemed to be reliable.

Some titles appearing after 1980 are included, however the bibliography is considered particularly complete for the period up to 1980.

Presentation of the Bibliography and its Make-up

The bibliography is presented simply alphabetically by first author or corporate entity. Initially it was contemplated listing catalogues separately from other works, but it was found that some entries titled as catalogues were neither illustrated and or priced while some citations unacknowledged as catalogues by the author contained extensive well illustrated, priced listings and it was thus difficult to draw a clear distinction. It was felt that grouping by country, usage and the like could be handled better in a cross referenced index than grouping the citations.

The items cited are a motley bunch. They run from well illustrated scholarly type-set works printed on quality paper to unillustrated mimeographed tracts on newsprint, very often done by well intentioned and well informed students with small budgets. Without question many catalogues have had substantial press runs; many publications, particularly those on a restricted topic or area have had very small runs.

As suggested, many of the publications cited are now scarce items, particularly those published 75-100 years ago.

Fortunately the majority of the older publications are outdated by newer ones. With respect to rarity, for example, many of the entries are missing from both the U.S. Library of Congress and the collections of the British Museum.

It would have been useful to indicate a library source for each entry but this was deemed impossible *in toto* and only those items in the American Revenue Association library have been flagged. It is expected that in the not too distant future on-line computer access between U.S. philatelic libraries will make inter-library searching for titles comparatively easy for the determined researcher and a second edition of the bibliography might have an appended guide to sources.

No attempt has been made to provide a critique of the publications cited. It is expected that the date of publication, information on size evidenced by pagination, and commentary on presence of illustrations and pricing information given with many of the entries, will assist the user in determining what will best suit his particular requirements and warrant tracking down more obscure publications.

Each entry is numbered with gaps provided to allow insertion of additional listings. The entry's reference number and the author's name(s) is printed in bold face type. A few abbreviations are used, the meaning of most of which will be understood by the reader; those that many not be familiar would include: SA — see also; n.d. — no date; CCNY — Collectors Club New York; suppl. — supplement. Those items which are in the ARA Library are indicated by an asterisk (*) following the reference number.

And thus a start is made to acquire a bibliographic grasp of the world's literature related to fiscal philately.

Preface to Index to Bibliography

Entries in the bibliography are indexed under country name as appropriate to the contents as delineated in the title of the entry. The designations used are those employed by the American Philatelic Research Library (APRL). The 5 digit number in parentheses after the country name is a numeric code assigned by APRL for computer handling. The 2 to 4 digit numbers are to entries in the bibliography and those marked with an * are in the American Revenue Association library.

Except for Canada, Great Britain and the United States the numbers of bibliographic entries under any geographic designation are few and in general no attempt has been made to further categorize their entries in the index. For example

the user interested in material on revenue stamps of Brunei, with but a single entry, will need be content with that citation though it may not be exactly what is wished for. Those countries with but a few entries can be examined quickly. For countries with many entries, theirs have been classified under headings which seemed appropriate to the material at hand. Where a string of entries follow a heading the first number given is to the most recent publication on the subject, the second number to the second most recent publication etc.

Many "See" and "See also" entries are given to assist the user and which, in general, bring the index into conformity with APRL practice.
